#### **Emergency Overview**

#### Physical Description & Colour: Pale blue liquid.

#### Odour: Mild ammonia odour.

**Major Health Hazards:** May be harmful if swallowed. Causes serious eye damage. Causes skin irritation. May cause an allergic skin reaction.

#### **Potential Health Effects**

#### Inhalation:

**Short Term Exposure:** Available data indicates that this product is not harmful. In addition product is unlikely to cause any discomfort or irritation.

Long Term Exposure: No data for health effects associated with long term inhalation.

### Skin Contact:

**Short Term Exposure:** Available data indicates that this product is not harmful. It should present no hazards in normal use. However, product may be irritating, but is unlikely to cause anything more than mild transient discomfort. **Long Term Exposure:** Repeated exposure may cause skin dryness or cracking.

### **Eye Contact:**

This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other nonhazardous ingredients are also possible.

The SWA TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5-day working week. 
